MTO Gas Tax for Accessible Transportation for Calendar Year 2020

Since 1985 the Sunshine Coach Service has been providing fare-based, accessible transportation for people who are living with disabilities that render the use of conventional modes of public transportation inappropriate to their needs.

The Sunshine Coach Service receives annual funding from the Ministry of Transportation as part of the Dedicated Gas Tax Funds for Public Transportation Program. The Ministry's calculation of the amount of the annual funding is based on two factors: the total population being served and the number of trips (the "ridership") provided by the Service.

The continuation of this level of funding, as well as the inclusion of the population of the Township of Horton for Gas Tax calculation purposes, is contingent upon the Sunshine Coach Service's ability to demonstrate that a partnership exists between it and the Townships to which service is provided.

The existence of an on-going financial partnership with serviced townships is demonstrated in *two* critical ways:

- passing of a by-law declaring support for the Sunshine Coach Service, together with a statement of agreement that the Town of Renfrew will receive and be responsible for Dedicated Gas Tax Funds on behalf of the Township.

Sample wording:

- *BE IT RESOLVED THAT the TOWNSHIP OF HORTON supports the Sunshine Coach Service, and is committed to provide support annually to begin **Date** and agrees to the Town of Renfrew receiving and being responsible for, on our behalf, Dedicated Gas Tax funds from the Province of Ontario as the Host Municipality for the Sunshine Coach Service.*

- a financial contribution on an annual basis in support of the Sunshine Coach Service.

We request your consideration of furnishing a financial contribution for the year 2020 and would also very much appreciate the Township of Horton enacting a by-law in support of Sunshine Coach Service and providing a Certified Copy of the by-law to Keray O'Reilly, Treasurer for the Town of Renfrew, if your current by-law on file is not open ended and has expired.

This Minor Variance Application pertains to the subject lands: Concession 7, Pt lot 20 known as 137 Rex Lane, as shown on Key Map.

Purpose of this Minor Variance:

This property is zoned Limited Service Residential (LSR) under Comprehensive Zoning By-Law 2010-14, Side yard Setback Provisions Section 7.2 (e) requires a minimum of 3 meters for all buildings and structures. There is an existing legal non-conforming structure (Seasonal Dwelling with attached enclosed porch) located on the property. The owners have always been under the assumption the entire structure was on their own property due to old surveyor's information. Upon the Consent Application B98/17(3) Lot Addition, a new survey performed indicated the attached enclosed porch encroached the side yard property line by 0.7 metres onto the adjacent property. The owners are proposing to correct the encroachment and renovate the existing porch but will continue to encroach on the side yard setback by 2.90 metres, but it will be solely on their property. The main purpose of this is to correct an old mistake that was made many years ago, prior to this Zoning By-Law being in effect.

This application for Minor Variance is to reduce the minimum required side yard Setback from 3 metres to 0.01 metres.

BY-LAW NO. 2020-01

BEING A BY-LAW TO ESTABLISH TEMPORARY BORROWING

WHEREAS Section 406 of the Municipal Act, 2001, as amended, authorizes a municipality to temporarily borrow until taxes are collected and other revenues are received;

WHEREAS the Council of the Township of Horton (the "Corporation") deems it necessary to borrow the sum of Five Hundred Thousand Dollars (\$500,000.00) to meet current expenditures of the Corporation for the year;

BE IT THEREFORE ENACTED as a By-Law of the Corporation as follows:

1. The Mayor or Deputy Mayor and CAO/Clerk or Treasurer are hereby authorized to borrow on behalf of the Corporation from THE TORONTO-DOMINION BANK (the "Bank") from time to time by way of promissory note or bankers' acceptance a sum or sums not exceeding at any one time Five Hundred Thousand Dollars (\$500,000.00) to meet, until the taxes are collected and other revenues are received, current expenditures of the Corporation for the year 2020.

2. The Mayor or Deputy Mayor and CAO/Clerk or Treasurer are hereby authorized to sign, make or draw on behalf of the Corporation and to furnish to the Bank from time to time promissory notes or bankers' acceptances for the sum or sums so borrowed with interest or any other charges at such rates as the Bank may from time to time determine.

3. The Mayor or Deputy Mayor and CAO/Clerk or Treasurer are hereby authorized and directed to furnish to the Bank at the time of each borrowing and at such other times as the Bank may from time to time request, a statement showing the nature and amount of the estimated revenues of the current year not yet collected or where the estimates for the year have not been adopted, a statement showing the nature and the amount of the estimated revenues of the Corporation as set forth in the estimates adopted for the next preceding year and also showing the total of any amounts borrowed in the current year and in any preceding year that have not been repaid.

4. All sums borrowed from the Bank and any interest thereon and any other charges in connection therewith shall, be a charge upon the whole of the revenues of the Corporation for the current year and any preceding years as and when such revenues are received and that the Mayor or Deputy Mayor and CAO/Clerk or Treasurer are hereby authorized to sign on behalf of the Corporation and to furnish to the Bank an Agreement or Agreements of the Corporation charging the said revenues of the Corporation with payment of all sums borrowed from the bank and any interest thereon and any other charges in connection therewith.

5. The Mayor or Deputy Mayor and CAO/Clerk or Treasurer are hereby authorized and directed to apply in payment of all sums borrowed from the Bank, and of any interest thereon and any other charges in connection therewith, all of the moneys hereafter collected or received on account or realized in respect of the taxes levied for the current year and for any preceding years and all of the moneys collected or received from any other source.

SECURITY AGREEMENT MUNICIPALITIES AND SCHOOL BOARDS

To: THE TORONTO-DOMINION, (the “Bank”)

The Corporation represents and warrants that the whole or any part or parts of the revenues of the Corporation are not subject to any prior charge, except as disclosed to the Bank in writing.

BY-LAW No. 2020-02

BEING A BY-LAW TO PROVIDE FOR AN INTERIM TAX LEVY AND TO PROVIDE FOR THE PAYMENT OF TAXES.

WHEREAS Section 317(1) of The Municipal Act, 2001, provides that the Council of a local municipality, before the adoption of the estimates for the year under Section 290, may pass a by-law levying amounts on the assessment of property in the local municipality rateable for local municipal purposes.

WHEREAS Section 317(3), p.(1) of The Municipal Act, 2001, provides that the amount levied on a property, shall not exceed 50 percent of the total amount of taxes for municipal and school purposes levied on the property for the previous year.

WHEREAS Section 317 (3), p. (3), of The Municipal Act, 2001, provides that for the purposes of calculating the total amount of taxes for 2019, if any taxes for municipal and school purposes were levied on a property for only part of the previous year, because assessment was added to the tax roll during the year, an amount shall be added equal to the additional taxes that would have been levied on the property if the taxes had been levied for the entire year, 2019.

WHEREAS section 317 (9) of The Municipal Act, 2001, provides that if the council of a municipality is of the opinion that the taxes levied under subsection (1) on a property are too high or too low in relation to its estimate of the total taxes that will be levied on the property, the council may adjust the taxes on the property to the extent it considers appropriate.

NOW THEREFORE the Council of the Corporation of the Township of Horton hereby enacts as follows:

1. **THAT** an effective tax rate, for each property class, amounting approximately to 50 per cent of the 2019 tax levied for Upper-Tier, Lower-Tier and Education purposes, be applied against the whole of the 2019 assessment for real property in all classes to generate an interim tax levy.
2. **THAT** the said interim tax levy shall become due and payable in two instalments due on the 28th day of February 2020 and the 29th day of May 2020.
3. **THAT** on all taxes of the interim levy, which are in default on the first day after the due date, a 1.25 per cent penalty shall be added and thereafter a penalty of 1.25 per cent per month will be added on the 1st day of each and every month the default continues, until December 31st, 2020.
4. **THAT** the collector is hereby authorized to mail or cause the same to be mailed to the residence or place of business of such person indicated on the last revised assessment roll, a written or printed notice specifying the amount of taxes payable.
5. **THAT** taxes are payable at the Township of Horton Municipal Office, 2253 Johnston Rd., RENFREW, ON K7V 3Z8.
6. **THAT** the Collector and/or Treasurer are hereby empowered to accept part payment from time to time on account of any taxes due.
7. **THAT** this By-Law shall come into force and take effect immediately upon the passing thereof.

CORPORATION OF THE TOWNSHIP OF HORTON**BY-LAW NO. 2020-06****A BY-LAW TO CONFIRM PROCEEDINGS OF
THE COUNCIL OF THE TOWNSHIP OF HORTON
AT THE REGULAR COUNCIL MEETING HELD JANUARY 7TH, 2020**

WHEREAS Subsection 5(1) of the Municipal Act, 2001, S.O. 2001, Chapter 25, as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS Subsection 5(3) of the said Municipal Act provides that the powers of every Council are to be exercised by by-law;

AND WHEREAS it is deemed expedient and desirable that the proceedings of the Council of the Corporation of the Horton at this meeting be confirmed and adopted by by-law;

THEREFORE the Council of the Township of Horton enacts as follows:

1. That the Head of Council and proper officers of the Corporation of the Township of Horton are hereby authorized and directed to do all things necessary to give effect to the said action or to obtain appropriate approvals where required, except where otherwise provided, and to affix the Corporate Seal of the Corporation of the Township of Horton to all such documents.
3. That this By-Law shall come into force and take effect upon the passing thereof.
